

## EMF CREDITS – SRI LANKA

1. Does a compulsory licence regime (s) exist ? If so describe its operation eg. Must be licensed to practice engineering and sign off engineering works.

**There is no compulsory licensing requirement in general. However for certain specific activities licensing is required**

2. Does an voluntary registration regime(s) exist ? If so, describe its operation, and the activities that can be only performed by registered persons, e.g. only registered persons allowed to sign off construction related work and devices inspected under occupational safety and health regulations.

**Voluntary registration/licensing exist for practise in specific areas. E.g. registered structural engineers may only certify building designs, design and certification of installation by registered electrical engineers is required prior to receiving supply, and regular boiler / pressure vessel certification by licensed engineers is mandatory.**

3. Describe the credits that will be given to any person registered on any section of the IRPE without the need to form any further agreements beyond the EMF (i.e. without bilateral) e.g.
  - a. Credits for holding a suitable qualification  
**Credits for local academic qualifications accredited by the IESL Accreditation Board and foreign qualifications recognised under the Washington Accord.**
  - b. Credits for 7 years experience  
**Yes**
  - c. Credits for 2 years responsible charge  
**Yes**
  - d. Credit for demonstrating competence to the agreed international standard (other than local knowledge)  
**Yes – subject to written submission and interview**
  - e. Credit for sufficient CPD (last 5 years)  
**Yes - on an average of 50 CPD hours per annum**
